- ✓ Warranty information (providers/vendors and expiration dates)

Inventory assignments give board staff the opportunity to know when, how, and in what condition assets were provided to students and when they were returned. In Equipment Online, each asset will have an assignment history as well, enabling the board to easily track and support the asset for multiple students across multiple schools over time.

When an asset is retired for reasons of obsolescence, damage, theft, or transfer to another board, the item can be archived in Equipment Online, removing it from active inventory while making it available for future reporting or accountability purposes.
