Child welfare agencies must continually adapt, reshape, and rethink the best way to move forward to protect the most vulnerable population: children. A critical part of a strong child welfare system is having committed, prepared, and loving foster and adoptive parents.

In fiscal year 2020, over 407,000 children across the country were in foster care; of those children, nearly 64,000 remained in foster care awaiting adoption for an average of 20 months after their parents' rights had been terminated.¹ The massive foster care population, coupled with a rapidly decreasing number of licensed foster parents, has created a gap in the child welfare system. In 2018, reported rates of foster parent turnover were as high as 30-50 percent.² It is anticipated that, with the COVID-19 pandemic, these figures continue to remain high. This has led to a growing emphasis on the need for child welfare agencies to prioritize more effective foster home licensing, recruitment, retention, and adoption processes.
