# Supplemental Payment Programs for Emergency Medical Services (EMS)

Medicaid payment rates for ambulance services are often 70 percent less than the cost of providing those services. With state budgets under significant pressure, the prospects for addressing this inequity with traditional measures are dim. However, there is another option. State Medicaid agencies and the Emergency Medical Services (EMS) community can work together to cover the shortfall by taking advantage of an innovative reimbursement mechanism offered by the federal government. 
